## **Legion Letter**

27 August 2021 File: 29-1 Dear Member of Parliament: On behalf of The Royal Canadian Legion (the Legion) I am sharing our 2021 "It's our duty" position paper. This paper outlines our organization's advocacy agenda and includes recommendations for government leaders of all parties. These are the issues we know are essential to the well-being of our Veterans and their families and must be considered seriously. We develop and update our advocacy positions annually, based on feedback from our members, our experiences working with Veterans and partners across the country, and progress on the mandates presented to Veterans Affairs Canada and the Department of National Defence. We are appreciative of government efforts already underway, but we must all strive to do more. Some items have seen no tangible progress for years, which is unacceptable. Among other priorities, we need to see: • Immediate tackling of the backlog of disability applications; • culture change within the CAF related to reporting and handling of sexual misconduct; • a sharper focus on homelessness including a pan-Canadian strategy to combat Veteran homelessness; • widespread improvements to the long-term care system. Our position paper provides a brief outline of specific target areas, and we look forward to working with all elected representatives to improve life for our Veterans and their families. We will continue to closely monitor progress and share feedback. Canada now has sufficient background and evidence-based input from support organizations to improve things dramatically – right now. We ask for fewer reports and meetings to rehash the same problems and concepts, and we need to see immediate action! After reading the following information you may forward any questions or

## • Veterans' Issues and the Upcoming Federal Election

With respect to the current federal election campaign, I am taking the liberty of attaching the NCVA position paper which calls for:

- 2.the adoption of bold and creative measures to accelerate the establishment of fast-tracking protocols and automatic entitlements for outstanding veterans' claims in order to alleviate the intolerable backlog and wait time crisis, which has only been compounded by Covid-19; and
- 3.the establishment of a comprehensive program model that would essentially treat all veterans with parallel disabilities in the same manner as to the application of benefits and wellness policies through a "one veteran one standard" approach.

There is no question that Canadian veterans and their families will be closely monitoring all federal leaders to determine which party is prepared

to make a substantial commitment to rectifying the shortfalls and inequities which continue to be found in veterans' legislation.

We have underlined the fact that there are almost 700,000 veterans in Canada today and, when family, friends and supporters are considered, this number of potential voters is not without significance. The basic question remains: which federal party will stand up for veterans in this election campaign and finally address the discrimination and injustice which remains in relation to veterans' pension and benefits (the "elephant in the room")?

## **Education and Training Benefit**

1.

Thinking of going back to school after your career in the military? Get financial help to go to college, university, technical school, or a short-term program.

### About this program

If your studies have been affected by COVID-19 or you are thinking of applying for the Education and Training Benefit, there is <u>important information</u> you need to know.

Getting additional training, a certification, a degree or a diploma can help you be more competitive in the workforce; setting you apart from other applicants. Whether you are continuing a learning program or just starting out, the Education and Training Benefit can help finance the education you need to reach your career goals.

The Education and Training Benefit is not limited to formal post-secondary training. A smaller amount of funding is also available for short courses, such as those aimed at career and personal development. This can include business boot camps, workshops and seminars.

The Education and Training Benefit is a taxable benefit.

## Do you qualify?

You should apply for the Education and Training Benefit if:

- •you were honourably released from the Canadian Armed Forces (Regular or Reserve Force) on or after April 1, 2006, or are a member of the Supplementary Reserve and;
- •you meet the "length of service" requirement:
  - •at least 12 years of authorized days of CAF Service (4382 days) to receive up to \$84,311.24 (2021) or
  - •at least 6 years of authorized days of CAF service (2191 days) to receive up to \$42,155.62 (2021).
- 1) You have up to 10 years following your release date to receive this funding. If you released from the Canadian Armed Forces between 1 April 2006 and 31 March 2018, you have until 1 April 2028 to receive the funding.

Members of the Supplementary Reserve who honourably released between 1 April 2018 and 4 July 2019 have 10 years from date of release to receive funding.

Members who honourably released on 5 July 2019 have until 5 July 2029, and those who transferred in after 5 July 2019 have 10 years from the date of last transfer.

Please note: You cannot receive this funding while you are participating in VAC's Rehabilitation and Vocational Assistance program, or if you are receiving the Canadian Forces Income Support.

How to apply

Before you apply

If you're not sure what education to pursue, consider applying for <u>Career Transition Services</u> first. This program will give you access to a trained career coach. They will work with you to help you find your best educational or training path.

Download the application form. Then, drop it off at a <u>VAC office or CAF Transition</u> <u>Centre</u>. You can also mail your completed application directly to the address listed on the form.

### Build your education plan

If you are approved for funding, you will then submit your education and training plan. The first step is to think about your options. Here are some things to consider:

- •Are you interested in pursuing a university degree? A trade school? A few workshops?
- •How many years does it usually take to complete the program?
- •Will you need to work while going to school?
- •Do you have other commitments which might limit the time you can dedicate to your studies?

Your answers to these and other questions will help you build your plan. It can be a lot to think about. Fortunately, most Veterans who qualify for this benefit are also eligible for VAC's <u>Career Transition Services</u>, which can provide one-on-one help to:

- •Choose the field of study that is right for you,
- •plan your studies to suit your circumstances,
- complete your forms, and
- •support your search for a job when you have completed your courses.

We need to receive your completed plan in advance of your course or period of study (e.g. semester) before we can send you any funds. Unfortunately, we are unable to provide retroactive payments.

## Submit your education plan

If you use <u>Career Transition Services</u>, your career coach will help you submit your plan. If you are doing this on your o wn, there are two application forms to choose from – one for a formal program and one for a short course. You can submit your plan through <u>My VAC Account</u> or you can download the plan and mail it to us.

### Formal program

The <u>formal program plan</u>requires information such as number of courses, cost of the program and start/end dates. This helps us calculate your payment plan to ensure you have enough funding for the duration of your program. If we need more information from you, we will contact you. Once your plan is approved, you will receive a letter detailing the total amount you will receive and your payment schedule.

#### Short course

You should fill out the <u>short course plan</u>when the course you want is short term and will not result in a college or university certificate, diploma or degree. For example:

- •small business/entrepreneurial boot camps,
- continuing education,
- ·workshops,
- certification or professional designations, or
- •other professional development.

### Monitor your progress

When you finish a period of study (e.g. semester), you will complete and submit the <u>Education and Training Benefit – Monitoring Form (VAC 1550)</u>. This form is required before we can send the next payment in your schedule. When you submit the monitoring form, you will also need to include:

- •Proof of completion of the recently finished period of study (e.g. transcript), and
- •Proof of enrollment in the upcoming period of study (e.g. confirmation of registration).

To ensure that these documents reach VAC quickly, we recommend uploading the monitoring form through <u>My VAC Account</u>. Once VAC receives your completed form, your next payment will be issued.

Note: We can only issue payments within 60 days of the start of your study period.

## The graduate bonus

After you complete your plan and achieve your diploma, degree or certification, you can apply for the "completion bonus." All you need to do is submit the <a href="Education and Training Benefit - Completion Bonus (VAC 1572)">Education and Training Benefit - Completion Bonus (VAC 1572)</a>, along with proof of your achievement, and you will receive an additional \$1,000.

The <u>Education and Training Benefit – Applicant Guide</u>(PDF) also covers all of the above steps from applying to this program through to your graduation.

### Related programs

<u>Career Transition Services</u>- Access to a career counselor for Veterans who want to find a new job.

<u>Vocational rehabilitation</u>- Coaching, support and any other training you need to return to work or find a new job after an injury.

<u>Transition Interview</u> – Before you release, a meeting to provide information on VAC programs and services available to you and your family.

### Information for education and training institutions

Veterans of the CAF have gained world-class skills and experience throughout their military careers that can translate very well into the classroom and workforce. The Education and Training Benefit will give many of these Veterans the opportunity and funding to participate in post-secondary education and other career development training programs.

## Frequently asked questions

If I apply for the benefit and get declined, can I appeal?

Yes. If you are not satisfied with a decision you may apply in writing for a review. Learn more about your <u>review and appeal options</u>.

How do I change or amend my plan?

After your ETB plan has been approved, circumstances may arise that may make you want to change your plan. For example, the course load is too heavy, or you have experienced a disruption in your personal life. If you want to make a change to your education plan, you must advise VAC immediately by completing and submitting the <a href="Education and Training Benefit">Education and Training Benefit</a> – Plan Amendment (VAC 1573). We will evaluate your updated plan, and if approved, will recalculate your payment schedule for the remaining periods of study.

I am a Reservist. Do I qualify for the Education and Training Benefit?

Yes, as of 5 July 2019, members of the Supplementary Reserve are eligible for the Education and Training Benefit. Serving members of the Canadian Armed Forces (Regular Forces or Reserves) are not eligible for the Education and Training Benefit, except for members of the Supplementary Reserve. Also, the Education and Training Benefit is available to Veterans who honourably released on or after 1 April 2006, or members of the Supplementary Reserve and have completed a minimum of six years (2191 paid days) of CAF service. The calculation of service includes Regular or Reserve Force service, or a combination of both. The calculation is completed through DND pension services.

Do family members qualify for the Education and Training Benefit?

No. This benefit is for Veterans only. But there are other options for family members. Survivors, spouses and common-law partners may be able to access <u>vocational assistance</u>if the Veteran is ill or injured and unable to participate in vocational rehabilitation. Also, the <u>Education Assistance Program</u> supports children of certain deceased Veterans and members of the Canadian Armed Forces.
